Mr. Colunga reported:

• CEO/Head Start Director Reported to the Board of Directors
Updated BOD on the COVID-19 Staff Vaccination progress and provided a status report on

how many staff have not been vaccinated. In total, 11 out of 164 employees have not yet been vaccinated or 92.9% vaccination.

After October 31, 2021 as part of a condition for employment, any KAF, Inc. employee who has not been vaccinated will be placed on administrative leave without pay, pending final disposition of their case. The agency will permit waivers from taking the vaccine, under the following conditions: (1) medical reasons (2) religious reasons.

For these cases, the CEO/Head Start Director will review each on a case by case basis for approval. Any waiver granted for either of the conditions being met, will require employees to get a weekly COVID Test and results at the start of each work week.

- Human Resources Department CEO/Head Start Director reported some shifting and affirmation of job duties for the HR staff and this process will continue as the department aligns with their job assignments.
- The Policy Council met on October 25, 2021 and the agenda and PC information packet was shared with the KAF, Inc. Board of Directors. All approval items presented to the PC were discussed in detail and approved by the Policy Council.

Old Business:

- Under Old Business a report was given by the CEO/Head Start Director regarding the reported past due property taxes for the Carrizo Springs Center. The staff are working with Purdue, Brandon Law firm to correct the charge, since the agency is a Non-Profit 501 C3 and thus, no subject to these taxes.
- Also, under Old Business a brief report was presented on the funding opportunity for the Victoria service area. At this time the funding announcement is forecasted only will be officially announced for competition sometime in November 2021.

New Business:

The CEO/Head Start Director presented the following items for review, consideration and approval.

- The CEO presented the BOD, the time clock policy, thus requiring every employee to digitally clock in at their designated assigned worksite.
- The CEO presented a "Flexible or Alternative Work Assigned and/or Location policy, thus allowing the agency the flexibility to management employee's assigned work locations to an area that would be advantageous to both employer and employee. The flexibility will allow the organization to retain employees and/or create work from home assignments consistent with CDC regulations and pandemic forecasts.
- The CEO presented the BOD an attendance policy and the Attendance Point System for Non-Exempt Employees Procedure that will provide supervisors additional tools to manage chronic absenteeism at the centers.
- The Policy Council Agenda and Minutes of September 27, 2021 were presented to the BOD so that both groups could be aligned with what each group's business and what was approved/disapproved.

Ms. Sonia Guerrero moved that the entire reports, policies and other information be approved by the board of directors.
